

## YELLOWCARD BETTER DAYS SWEEPSTAKES

These rules are the terms and conditions (the "**General Terms and Conditions**") of the Yellowcard ft Good Charlotte Better Days Sweepstakes (the "**Sweepstakes**"). This Sweepstakes is sponsored by 11-7 Recording Corp. d/b/a Better Noise Music with an address c/o Fox Rothschild LLP, 101 Park Avenue, 17<sup>th</sup> Floor New York, NY 10178 (the "**Sponsor**"). By entering the Sweepstakes you confirm your acceptance of these General Terms and Conditions and any other instructions or directions available on the Sweepstakes website <https://www.yellowcardplaylist.com/> (the "**Sweepstakes Website**" and together with the General Terms and Conditions, the "**Official Rules**"). Please read the Official Rules carefully. If you do not agree to the Official Rules, do not enter this Sweepstakes.

Sponsor reserves the right to modify or amend at any time the Official Rules and/or to terminate the Sweepstakes completely at any time at its sole discretion by posting an amended version thereof on the Sweepstakes Website and/or on its social media platforms.

### 1. Eligibility

(a) No purchase necessary. The Sweepstakes is open to persons who are legal residents of the United States eighteen (18) years of age or older, as of the date of entry, who have an active e-mail account, Internet access, and an active Spotify or Apple Music account as of the beginning of the Sweepstakes period (an "**Entrant**"). Employees of Sponsor and its parent companies, affiliates or subsidiaries or advertising, promotion, fulfillment or other coordinating agencies, individuals providing services to Sponsor through an outsourcer or temporary employment agency during the Sweepstakes period, and their respective immediate family members and persons living in their same household, are not eligible to participate in the Sweepstakes. Anyone who attempts to defraud or in any way tamper with the Sweepstakes will be ineligible. Participation in the Sweepstakes constitutes Entrant's full and unconditional agreement to and acceptance of the Official Rules.

(b) The winner will be required to provide us with the following information in order for us to send the reward: Full Name of the Entrant, Complete Postal Address, Zip Code, State, Phone Number and Email Address.

(c) For the avoidance of doubt, all issues of eligibility will be decided by Sponsor in its sole discretion.

(d) Any entry or other action in respect of the Sweepstakes made by an ineligible person will be null and void.

### 2. Entries

(a) During the Submission Period (as defined below), Entrants may visit the Sweepstakes Website and login via Spotify or Apple Music. To participate, Entrants must perform various interactions on the Spotify or Apple Music platform and/or the Sweepstakes Website, including, without limitation, following the artists profile for the band collectively p/k/a "Yellowcard" and "Good Charlotte" ("**Artists**"), following Artist's official newsletters, saving the artist playlists, and latest album (collectively, a "**Submission**") to earn entry (an "**Entry**"). This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Spotify or Apple Music. Entrant understands that Entrant is providing its information to Sponsor and not to Spotify or Apple Music.

(b) Entries shall be accepted during the period beginning at 12:01am ET on January 28, 2026 and ending at 11:59pm ET on February 11, 2026 (the "**Submission Period**"). The Submission Period may be extended by Sponsor in its sole discretion. All Submissions must be received during this Submission Period to be eligible to win an Award (as defined below).

(c) No mechanically reproduced mail-in Entries are allowed and any use of robotic, automatic, programmed or similar entry methods will void all such Entries by such methods.

(d) Only one Entry per person, household and e-mail address is permitted, regardless of method of Entry. Entrants submitting multiple Submissions or violating any of these Official Rules may be disqualified.

(e) By submitting a Submission, each Entrant grants Sponsor a worldwide, exclusive, royalty-free, perpetual and irrevocable license to copy, modify, create derivate works, publish, display, broadcast, rebroadcast, sell and distribute such Submission for any purpose. Entrant agrees not to assert any moral rights in any Submissions against Sponsor or any of its Affiliates (as defined below) and Entrant waives any and all claims against Sponsor and its Affiliates in respect of any moral rights in any Submissions. Entrant moreover grants Sponsor the right to reveal and publish their name, photo, portrait, voice, likeness, image and biographical information for news, publicity, advertising, promotional purposes, trade, information, and public relations without any further notice, review, consent, compensation, or remuneration and Entrant grants Sponsor the right to print, publish, broadcast, distribute and use the foregoing in any media known now or hereafter developed, in perpetuity, worldwide.

### **3. Selection of Winner**

(a) The winner will be selected by the Sponsor at random on February 18, 2026 from among all eligible entries collected during the Submission Period, in accordance with the Official Rules (the "**Winner**"). Any decision of Sponsor regarding the selection of any Winners is final. Sponsor will not consider any appeals subsequent to the selection of a Winner. The odds of winning will depend on the number of eligible Entries received, according to the eligibility requirements of the Sweepstakes.

(b) Prizes won by an eligible Entrant who is a minor in his/her jurisdiction of residence at the time of selection will be awarded to such minor's parent or legal guardian who must sign and return all required documents requested by Sponsor.

(c) Sponsor may extend the Submission Period in its sole discretion. Any extension of the Submission Period will be detailed on the Sweepstakes Website and/or on social media platforms, together with any revised Submission Period and date on which Sponsor expects that the Winner will be selected.

(d) The Winner will be notified by email within fourteen (14) business days (the "**Notification Period**") of their selection.

(e) Winners may be required to sign and return an affidavit of eligibility and publicity/liability release within seven (7) days of notification.

(f) In the event that Sponsor cannot for any reason contact the Winner during the Notification Period, or when the Winner is ineligible, fails to claim the Award and/or, where applicable, an affidavit of eligibility and publicity/liability release from the Winner is not timely received, is incomplete or modified, Sponsor reserves the right in its sole discretion to select another Winner(s) or to determine that there shall be no Winner. Sponsor further reserves the right to postpone and/or cancel the Sweepstakes at any time and at its sole discretion.

(g) Sponsor reserves the right to select an alternate Winner in the event that Sponsor has reasonable grounds for believing that any selected Winner has contravened any of the Official Rules. (h) In the event of a dispute regarding who submitted an Entry, the Entry will be deemed submitted by the Authorized Account Holder of the e-mail account specified in the Entry. "**Authorized Account Holder**" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. No automatically generated entries will be accepted.

Except as specifically mentioned herein, any and all expenses relating to the Award shall be solely the responsibility of Winners including, without limitation, any shipping and/or delivery costs and expenses. Approximate retail value of the Award for **Grand Prize** is Two Thousand and Eight Hundred Dollars (USD \$2,800.00). Any difference between the stated approximate retail value and actual value of the Award will not be awarded to the Winner. Winner is solely responsible for any federal, state and local taxes in connection with the Award. Sponsor will deliver the Award using the email and/or other contact details provided by the Entrant within 6–8 weeks of receipt of a notification of their selection as a Winner. You consent and accept that such Service-Related Messages may include reminders and notifications regarding your account status, including with respect to the blocking of messages as aforesaid.

#### **6. Liability Release**
